On July 7, 2026, Shareholders of TruBridge, Inc (TBRG) voted concerning the proposed merger with a wholly-owned subsidiary of Inventurus Knowledge Solutions, Inc., subsidiary of Inventurus Knowledge Solutions Limited. The merger was approved and subsequently consummated before the open on July 9, 2026. As a result, each existing TBRG Common Share will be converted into the right to receive \$26.25 net cash per share.

**Contract Adjustment**

**Date:** July 9, 2026

**New Deliverable  
Per Contract:** \$2,625.00 Cash (\$26.25 x 100)

Settlement in TBRG options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of TruBridge, Inc options whose expiration dates are after 07-17-2026 will have their expiration dates advanced to 07-17-2026. Expiration dates occurring before 07-17-2026 (e.g., Flex options) will remain unchanged.

All TruBridge, Inc options will utilize a \$.01 exercise threshold.

New expiration date: 07-17-2026

Existing American-style TruBridge, Inc options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
