On July 22, 2026, Shareholders of Taylor Morrison Home Corporation (TMHC) voted concerning the proposed merger with WXYZ Merger Sub, Inc., a wholly-owned subsidiary of Berkshire Hathaway Inc. The merger was approved and subsequently consummated before the open on July 24, 2026. As a result, each existing TMHC Common Share will be converted into the right to receive \$72.50 net cash per share.

Settlement in TMHC options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Taylor Morrison Home Corporation options whose expiration dates are after 08-21-2026 will have their expiration dates advanced to 08-21-2026. Expiration dates occurring before 08-21-2026 (e.g., Flex options) will remain unchanged.

All Taylor Morrison Home Corporation options will utilize a \$.01 exercise threshold.

New expiration date: 08-21-2026

Existing American-style Taylor Morrison Home Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
