Subject: Adjusted Tradr 2X Short IREN Daily ETF – Cash In Lieu Settlement
Adjusted Option Symbol: IREZ1

Adjusted Tradr 2X Short IREN Daily ETF options were adjusted on July 21, 2026 (See OCC Information Memo #59355). The new deliverable became 1) 33 Tradr 2X Short IREN Daily ETF (IREZ) Shares and 2) Cash in lieu of approximately 0.3333 fractional IREZ Shares. Only settlement of the cash portion of IREZ1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$21.6339 per whole IREZ share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

$$0.3333 \times \$21.6339 = \$7.21 \text{ per IREZ1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 21, 2026 through July 24, 2026, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the IREZ1 options are as follows:

New Deliverable

Per Contract: 1) 33 Tradr 2X Short IREN Daily ETF (IREZ) Shares
2) \$7.21 Cash

Strike Prices: Unchanged

CUSIP: IREZ: 46152N827

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The IREZ component of IREZ1 exercise/assignment activity from July 21, 2026 through July 23, 2026, has settled through National Security Clearing Corporation (NSCC). The \$7.21 cash amount will be settled by OCC.

Pricing

The underlying price for IREZ1 will be determined as follows:

$$\text{IREZ1} = 0.33 (\text{IREZ}) + 0.0721$$

For example, if IREZ closes at 22.33, the IREZ1 price would be calculated as follows:

$$\text{IREZ1} = 0.33 (22.33) + 0.0721 = 7.44$$
