Subject: Adjusted PSQ Holdings, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: PSQH1

Adjusted PSQ Holdings, Inc. options were adjusted on July 13, 2026 (See OCC Information Memo #59344). The new deliverable became 1) 6 PSQ Holdings, Inc. (PSQH) Class A Common Shares and 2) Cash in lieu of approximately 0.6667 fractional PSQH Shares. Only settlement of the cash portion of PSQH1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$4.82 per whole PSQH share will be used to determine the cash in lieu amount at a rate of 0.6667. Accordingly, the cash in lieu amount is:

$$0.6667 \times \$4.82 = \$3.21 \text{ per PSQH1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 13, 2026 through July 27, 2026, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the PSQH1 options are as follows:

New Deliverable

Per Contract: 1) 6 PSQ Holdings, Inc. (PSQH) Class A Common Shares
2) \$3.21 Cash

Strike Prices: Unchanged

CUSIP: PSQH: 693691206

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The PSQH component of PSQH1 exercise/assignment activity from July 13, 2026 through July 24, 2026, has settled through National Security Clearing Corporation (NSCC). The \$3.21 cash amount will be settled by OCC.

Pricing

The underlying price for PSQH1 will be determined as follows:

$$\text{PSQH1} = 0.06 (\text{PSQH}) + 0.0321$$

For example, if PSQH closes at 3.34, the PSQH1 price would be calculated as follows:

$$\text{PSQH1} = 0.06 (3.34) + 0.0321 = 0.23$$
