Adjusted Option Symbol: FMX1

Adjusted Fomento Economico Mexicano, S.A.B. de C.V. (adjusted option symbol FMX1) options were adjusted on October 16, 2025, January 16, 2026, April 22, 2026, and again on July 15, 2026 (See OCC Information Memos #57518, #58263, #58907, and #59328). The new deliverable became 1) 100 Fomento Economico Mexicano, S.A.B. de C.V. (FMX) American Depositary Shares and 2) Approximately \$423.96 Cash (\$356.20 + (approximately \$0.677649 x 100)). Only settlement of the cash portion of FMX1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that the final cash distribution rate is \$1.032329 (\$1.147033 gross dividend less \$0.1147033 withholding tax) per FMX share held.

Now that the final cash distribution amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 15, 2026 through July 29, 2026, to deliver the appropriate cash amount.

Terms of the FMX1 options are as follows:

New Deliverable

Per Contract: 1) 100 Fomento Economico Mexicano, S.A.B. de C.V. (FMX)
American Depositary Shares
2) \$459.43 Cash (\$356.20 + (\$1.032329 x 100))

Strike Prices: Unchanged

CUSIP: 344419106

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The FMX component of FMX1 exercise/assignment activity from July 15, 2026 through July 28, 2026, has settled through National Security Clearing Corporation (NSCC). The \$459.43 cash amount will be settled by OCC.

Pricing

The underlying price for FMX1 will be determined as follows:

$$\text{FMX1} = \text{FMX} + 4.5943$$

For example, if FMX closes at 132.15, the FMX1 price would be calculated as follows:

$$\text{FMX1} = 132.15 + 4.5943 = 136.75$$
