Distribution Settlement
Adjusted Option Symbol: FMX5

Adjusted Fomento Economico Mexicano, S.A.B. de C.V. (adjusted option symbol FMX5) options were adjusted on July 15, 2026 (See OCC Information Memo #59326). The new deliverable became 1) 100 Fomento Economico Mexicano, S.A.B. de C.V. (FMX) American Depositary Shares and 2) Approximately \$67.76 Cash (approximately $\$0.677649 \times 100$). Only settlement of the cash portion of FMX5 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that the final cash distribution rate is \$1.032329 (\$1.147033 gross dividend less \$0.1147033 withholding tax) per FMX share held.

Now that the final cash distribution amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 15, 2026 through July 29, 2026, to deliver the appropriate cash amount.

Terms of the FMX5 options are as follows:

New Deliverable

Per Contract: 1) 100 Fomento Economico Mexicano, S.A.B. de C.V. (FMX)
American Depositary Shares
2) \$103.23 Cash ($\1.032329×100)

Strike Prices: Unchanged

CUSIP: 344419106

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The FMX component of FMX5 exercise/assignment activity from July 15, 2026 through July 28, 2026, has settled through National Security Clearing Corporation (NSCC). The \$103.23 cash amount will be settled by OCC.

Pricing

The underlying price for FMX5 will be determined as follows:

$$\text{FMX5} = \text{FMX} + 1.0323$$

For example, if FMX closes at 132.15, the FMX5 price would be calculated as follows:

$$\text{FMX5} = 132.15 + 1.0323 = 133.18$$
