Nerdy Inc. (NRDY) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each NRDY Class A Common Share will be converted into the right to receive approximately 0.066667 (New) Nerdy Inc. Class A Common Shares. The reverse stock split will become effective before the market open on August 19, 2026. Cash will be paid in lieu of fractional shares.

Contract Adjustment

Option Symbol: NRDY changes to NRDY1

Contract Multiplier: 1

New Multiplier: 100 (e.g., for premium or strike dollar extensions 1.00 will equal \$100)

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Pricing

Until the cash in lieu amount is determined, the underlying price for NRDY1 will be determined as follows:

$$\text{NRDY1} = 0.066667 (\text{NRDY})$$

Delayed Settlement

The NRDY component of the NRDY1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the NRDY1 deliverable until the cash in lieu of fractional NRDY Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
