On June 12, 2026, BlackRock ETF Trust announced that it will terminate and subsequently liquidate the iShares U.S. Select Equity Active ETF (BELT). The last day of trading for BELT shares on NASDAQ will be August 12, 2026.

Between market close on or about August 12, 2026 and August 17, 2026 (the "Liquidation Date"), the Trust cannot assure that there will be a trading market for shares of the Fund. On the Liquidation Date, the Fund will automatically redeem the shares for cash based on the net asset value of the Fund.

OCC has been informed that the liquidation proceeds were distributed to BELT shareholders on August 17, 2026, in the amount of \$39.926954 per BELT share.

Contract Adjustment

The option symbol BELT will not change.

New Deliverable
Per Contract: \$3,992.70 Cash ($\39.926954×100)

BELT options, which were subject to delayed settlement from August 13, 2026 through August 14, 2026, will no longer be subject to delayed settlement, effective August 17, 2026. Settlement in BELT options will take place through OCC's cash settlement system.

Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of iShares U.S. Select Equity Active ETF options whose expiration dates are after 08-21-2026 will have their expiration dates advanced to 08-21-2026. Expiration dates occurring before 08-21-2026 (e.g., Flex options) will remain unchanged.

All iShares U.S. Select Equity Active ETF options will utilize a \$.01 exercise threshold.

Option Symbol: BELT

Existing Expiration: All months

New expiration date: 08-21-2026

Existing American-style iShares U.S. Select Equity Active ETF options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
