Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Pricing

Until the cash in lieu amount is determined, the underlying price for SAN1 will be determined as follows:

$$\text{SAN1} = 2.0548 (\text{SAN}) + 48.75$$

Delayed Settlement

The SAN component of the SAN1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the SAN1 deliverable until the cash in lieu of fractional SAN shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Background

On May 26, 2026, Shareholders of Webster Financial Corporation (WBS) voted concerning the proposed merger with Banco Santander, S.A. (SAN). The merger was approved and subsequently consummated on August 19, 2026. As a result, each existing WBS Common Share will be converted into the right to receive 2.0548 SAN American Depositary Shares plus \$48.75 Cash. Cash will be paid in lieu of fractional SAN shares.
