Skye Bioscience, Inc. (SKYE) has announced a 1-for-8 reverse stock split. As a result of the reverse stock split, each SKYE Common Share will be converted into the right to receive 0.125 (New) Skye Bioscience, Inc. Common Shares. The reverse stock split will become effective before the market open on August 24, 2026. Cash will be paid in lieu of fractional shares.

Contract Adjustment

Contract Multiplier: 1

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Pricing

Until the cash in lieu amount is determined, the underlying price for SKYE1 will be determined as follows:

$$\text{SKYE1} = 0.125 (\text{SKYE})$$

Delayed Settlement

The SKYE component of the SKYE1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the SKYE1 deliverable until the cash in lieu of fractional SKYE Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
