Effective on August 21, 2026, settlement of DXLG options exercise/assignment activity was subject to broker to broker settlement (see OCC Information Memo #59625). DXLG shares (CUSIP 25065K104) are now eligible for Continuous Net Settlement ("CNS") at the National Securities Clearing Corporation ("NSCC"). As a result, all exercise and assignment activity for DXLG options as of August 24, 2026 and thereafter for DXLG options will no longer be subject to broker to broker settlement and will settle through NSCC.

Any existing broker to broker obligations on DXLG exercise and assignment on August 21, 2026 will remain subject to broker to broker settlement.

The deliverable for DXLG options will remain the underlying 100 Destination XL Group, Inc. Common Shares.
