On September 18, 2026, Shareholders of Theravance Biopharma, Inc. (TBPH) will vote concerning the proposed merger with Zymeworks Merger Sub 1, a wholly-owned subsidiary of Zymeworks Inc. If the merger is approved and consummated, each existing TBPH Ordinary Share will be converted into the right to receive \$17.00 net cash per share plus one non-transferable Contingent Value Right (“CVR”).

Note: The CVRs represent a non-transferable contractual right to receive the contingent cash payment as described in the TBPH Proxy Statement dated August 21, 2026. The adjusted TBPH option deliverable will not include the non-transferable CVRs.

Exercise Consideration – TBPH options will not call for delivery of the CVRs. Call option holders who wish to receive the CVRs should exercise their options in sufficient time in advance of the contract adjustment. In all cases, it is the sole responsibility of persons holding call options seeking to receive the underlying securities to determine when to exercise their options.

Contract Adjustment

Date: Effective the opening of the business day after the merger is consummated.
Contract adjustment is expected to occur in the second half of 2026.

**New Deliverable
Per Contract:** \$1,700.00 Cash (\$17.00 x 100)

Settlement in TBPH options will take place through OCC’s cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an **acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
