On September 23, 2026, Shareholders of Bio-Techne Corporation (TECH) will vote concerning the proposed merger with EMD Holdings NewCo, Inc., a wholly-owned subsidiary of Merck KgaA, Darmstadt, Germany. If the merger is approved and consummated, each existing TECH Common Share will be converted into the right to receive \$73.00 net cash per share.

Contract Adjustment

Date: Effective the opening of the business day after the merger is consummated.
Contract adjustment is expected to occur by late 2026 or early 2027.

New Deliverable
Per Contract: \$7,300.00 Cash (\$73.00 x 100)

Settlement in TECH options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
