Subject: Holiday Processing September 7, 2026

CME will be open for trading for certain products on Monday, September 7, 2026. All trades will be processed with a trade date of September 8, 2026. Since September 7, 2026, is an OCC holiday, OCC will process a 10% holiday margin increase on accounts holding XCME positions on Friday, September 4, 2026. This holiday margin call will result in a collateral requirement in segregated futures accounts equal to the larger of (a) Daily Net Margins plus the 10% holiday margin call or (b) Customer Gross Margins. Proprietary accounts holding positions on this exchange are subject to a margin call equal to 10% of the sum of expected shortfall and stress test charges for those positions.

Please note that this increase is not reflected on the Account Summary by CMO Report or the Cash Settlement Breakdown Report. Firms drafted as a result of the holiday margin increase will be notified Friday morning. Clearing Members are responsible for requesting cash back via ENCORE after depositing alternative forms of collateral.
