Adjusted LivePerson, Inc. options were adjusted on October 13, 2025 (See OCC Information Memo #57501). The new deliverable became 1) 6 LivePerson, Inc. (LPSN) Common Shares, and 2) \$4.07 Cash.

On August 20, 2026, Shareholders of LivePerson, Inc. (LPSN) voted concerning the proposed merger with SoundHound AI, Inc. (SOUN). The merger was approved and subsequently consummated before the open on September 4, 2026. As a result, each existing LPSN Common Share will be converted into the right to receive 0.4673 SOUN Class A Common Shares. Cash will be paid in lieu of fractional SOUN shares.

LPSN1 options are expected to be further adjusted to reflect the merger consideration as described below.

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

## **Pricing**

Until the cash in lieu amount is determined, the underlying price for SOUN1 will be determined as follows:

$$\text{SOUN1} = 0.028038 (\text{SOUN}) + 0.0407$$

## **Delayed Settlement**

The SOUN component of the SOUN1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the SOUN1 deliverable until the cash in lieu of fractional SOUN shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
