Subject: Adjusted Nerdy Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: NRDY1

Adjusted Nerdy Inc. options were adjusted on August 19, 2026 (See OCC Information Memo #59580). The new deliverable became 1) 6 Nerdy Inc. (NRDY) Class A Common Shares and 2) Cash in lieu of approximately 0.6667 fractional NRDY Shares. Only settlement of the cash portion of NRDY1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$10.098773 per whole NRDY share will be used to determine the cash in lieu amount at a rate of 0.6667. Accordingly, the cash in lieu amount is:

$$0.6667 \times \$10.098773 = \$6.73 \text{ per NRDY1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of August 19, 2026 through September 08, 2026, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the NRDY1 options are as follows:

New Deliverable

Per Contract: 1) 6 Nerdy Inc. (NRDY) Class A Common Shares
2) \$6.73 Cash

Strike Prices: Unchanged

CUSIP: NRDY: 64081V208

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The NRDY component of NRDY1 exercise/assignment activity from August 19, 2026 through September 4, 2026, has settled through National Security Clearing Corporation (NSCC). The \$6.73 cash amount will be settled by OCC.

Pricing

The underlying price for NRDY1 will be determined as follows:

$$\text{NRDY1} = 0.06 (\text{NRDY}) + 0.0673$$

For example, if NRDY closes at 9.35, the NRDY1 price would be calculated as follows:

$$\text{NRDY1} = 0.06 (9.35) + 0.0673 = 0.63$$
