On October 14, 2026, Shareholders of Lantheus Holdings, Inc. (LNTH) will vote concerning the proposed merger with a wholly-owned subsidiary of Curium US Holdings LLC, a subsidiary of Curium BidCo S.à.r.l. If the merger is approved and consummated, each existing LNTH Common Share will be converted into the right to receive \$102.50 net cash per share plus one non-transferable Contingent Value Right (“CVR”).

Note: The CVRs represent the right to receive up to \$12.00 in cash upon the achievement of certain specified commercial milestones as described in the LNTH Proxy Statement dated September 8, 2026. The adjusted LNTH option deliverable will not include the non-transferable CVRs.

Exercise Consideration – LNTH options will not call for delivery of the CVRs. Call option holders who wish to receive the CVRs should exercise their options in sufficient time in advance of the contract adjustment. In all cases, it is the sole responsibility of persons holding call options seeking to receive the underlying securities to determine when to exercise their options.

Contract Adjustment

Date: Effective the opening of the business day after the merger is consummated.
Contract adjustment is expected to occur in the first half of 2027.

**New Deliverable
Per Contract:** \$10,250.00 Cash (\$102.50 x 100)

Settlement in LNTH options will take place through OCC’s cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an **acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
