Adjusted Tradr 2X Short NBIS Daily ETF options were adjusted on July 21, 2026 (See OCC Information Memos #59443). The new deliverable became 1) 33 Tradr 2X Short NBIS Daily ETF (NBIZ) Shares and 2) \$7.62 Cash.

Tradr 2X Short NBIS Daily ETF (NBIZ) has announced a 1-for-4 reverse stock split. As a result of the reverse stock split, each NBIZ Share will be converted into the right to receive 0.25 (New) Tradr 2X Short NBIS Daily ETF Shares. The reverse stock split will become effective before the market open on September 22, 2026. Cash will be paid in lieu of fractional shares.

Adjusted NBIZ2 options will be further adjusted to reflect the reverse split as described below:

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Pricing

Until the cash in lieu amount is determined, the underlying price for NBIZ2 will be determined as follows:

$$\text{NBIZ2} = 0.0825 (\text{NBIZ}) + 0.0762$$

Delayed Settlement

The NBIZ component of the NBIZ2 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the NBIZ2 deliverable until the cash in lieu of fractional NBIZ Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
