On September 8, 2026, Themes ETF Trust announced that it will terminate and subsequently liquidate the Themes US Small Cap Cash Flow Champions ETF (SMCF). The last day of trading of SMCF shares on Nasdaq was September 21, 2026, and the shares were subsequently delisted.

Shareholders who did not sell their SMCF shares before market close September 21, 2026, will receive cash equal to the amount of the net asset value of their shares on or about September 25, 2026.

OCC has been informed that the liquidation proceeds were distributed to SMCF shareholders on September 25, 2026, in the amount of \$38.716872 per SMCF share.

Contract Adjustment

The option symbol SMCF will not change.

New Deliverable \$3,871.69 Cash ($\38.716872×100)

SMCF options, which were subject to delayed settlement from September 22, 2026 through September 24, 2026, will no longer be subject to delayed settlement, effective September 25, 2026. Settlement in SMCF options will take place through OCC's cash settlement system.

Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Themes US Small Cap Cash Flow Champions ETF options whose expiration dates are after 10-16-2026 will have their expiration dates advanced to 10-16-2026. Expiration dates occurring before 10-16-2026 (e.g., Flex options) will remain unchanged.

All Themes US Small Cap Cash Flow Champions ETF options will utilize a \$.01 exercise threshold.

Option Symbol: SMCF

Existing Expiration: All months

New expiration date: 10-16-2026

Existing American-style Themes US Small Cap Cash Flow Champions ETF options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
